Methodology: We attempted to contact all international relations (IR) scholars in

the U.S. We define IR scholars as individuals who are employed at a college or university in a political science department or professional school and who teach or conduct research on issues

that cross international borders.

The poll was open May 31 – June 2, 2015. Of the 4,094 scholars across the U.S. that we contacted, 655 responded. The resulting response rate is approximately 16.0 percent, and the margin of error for the poll is +/- 3.51% percent. See the final page of this

report for a detailed breakdown of the demographic characteristics of respondents compared to the population of IR scholars identified by the TRIP project. In terms of tenure status and university type, our respondents were statistically indistinguishable from the general population of IR scholars in the U.S. However, female faculty were less likely to respond than their male counterparts as illustrated in the final table of this report.

We are pleased to share the results of the sixth Teaching, Research, and International Policy (TRIP) Snap Poll. With support from the Carnegie Corporation of New York, we field Snap Polls several times a year. Our polls provide real-time data in the wake of significant policy proposals, during international crises, and on emerging foreign policy debates. In this poll, we asked about Greece and the future of the Euro, international migration, FIFA, and free-trade agreements. How TRIP Snap Polls work


TRIP Snap Polls survey all IR scholars in the United States. To be included in our sample, individuals must be employed at a U.S. college or university in a political science department or professional school and teach or conduct research on issues that cross international borders. To date we have identified 4,094 individuals who fit these criteria. The Snap Poll was open for 51 hours from 11:59pm EST Sunday, May 31 to 11:59pm PST Tuesday, June 2. In this poll, 655 scholars responded to at least one question, a response rate of approximately 16.0 percent with a margin of error of +/- 3.51%. The number of responses to each question is listed below. In terms of tenure status and university type our respondents were statistically Indistinguishable from the general population of IR scholars in the U.S. However, female faculty were less likely to respond than their male counterparts as illustrated in the final table of this report.



Would Greece be better off if it stopped using the Euro as its currency?



Does conducting search-and-rescue operations for migrants traveling in international waters increase, decrease, or have no effect on future migration flows?







What effect will political disagreement among EU member states over migration policy have on the credibility of the Common Foreign and Security Policy (CFSP)?
























